

Policy on Packaging

Oriental Merchant has committed to the Australian Packaging Covenant ("the Covenant") and the packaging initiatives detailed in the Australian Packaging Covenant Organisation's strategic plan. To achieve this, Oriental Merchant will pursue the following 3 pillars and will strive to achieve performance levels stated in its action plan within the next 3 years:

Pillar 1: Resource Efficiency

- optimise packaging through sustainable design by using life cycle approach to reduce environmental impact without compromising product quality and safety and adopting and incorporating the Packaging Sustainability Guidelines
- continue to source supply chain solutions to recover packaging and with industry, collectively create sustainable closed loop economies

Pillar 2: Landfill Minimisation

- work towards efficient collection and recycling of packaging to reduce the amount of waste that goes to landfill
- engage in creating consumer awareness and influence disposal behaviour through on-pack labelling.

Pillar 3: Leadership

- explore and participate with signatories across the supply chain to improve packaging sustainability.

Oriental Merchant will strive to work with its suppliers through regular packaging reviews to achieve the set targets and will endeavour to build on the initiatives and processes to achieve the desired results.

Being a signatory to the Covenant, Oriental Merchant has the full support of its senior management to take all necessary action to pursue the pillars and key performance indicators that it has committed to.
